North Carolina Association of Local Health Directors Association Business Meeting June 19, 2025 – 9:30 am Cardinal Room, Six Forks Road

Meeting Called to Order - Dr. Rod Jenkins

On a humid Thursday morning President Dr. Rod Jenkins (Durham Co.) opened the meeting at 9:30 am and thanked everyone for attending.

Approval of Minutes - Joshua Swift

Minutes were distributed with the packet via email. President Jenkins asked for a motion for approval of the minutes.

Motion: Motion to approve was made by Marilyn Pearson (Johnston Co.) and seconded by Nina Oliver (Carteret Co.). No objections – minutes were approved by consensus.

Treasurer's Report - Joshua Swift

The Treasurer's Report was distributed with the packet via email. President Jenkins asked for a motion for approval of the Treasurer's Report.

Motion: Motion to approve was made by Marilyn Pearson (Johnston Co.) and seconded by Nina Oliver (Carteret Co.). No objections – Treasurer's Report was approved by consensus.

Budget Report - Joshua Swift

Budget was distributed with the packet via email. President Jenkins asked for a motion for approval of the minutes.

Motion to approve was made by Marilyn Pearson (Johnston Co.) and seconded by Nina Oliver (Carteret Co.). No objections – Budget was approved by consensus.

President's Report - Dr. Rod Jenkins

Dr. Jenkins thanked everyone for the Wednesday meetings at Six Forks. Rod introduced Lori Tremmel Freeman Director of NACCHO. He thanked Region 3 for hosting him in early June and appreciated the greatest region in North Carolina making him feel welcome. Rod mentioned the email that was sent to the Association and thank those who sent emails of appreciation. He encouraged the Health Directors to focus on what we can control. Dr. Jenkins encouraged the team to take care of themselves.

Medicaid Update - Jay Ludlam, Deputy Secretary Medicaid

Jay virtually shared with the association that he is tracking the state budget and federal budget. At the state both House and Senate have proposed budgets that do not fund the Medicaid Rebase. A rebase is when you take the cost of the current program and estimate the cost to run last year's programs for the

next year. There is a \$200 million shortfall in the current proposed budget. Driven by scheduled changes to the federal match rate, which is determined by NC economy which is a wealthier state.

Healthy Opportunities will be stopped on June 30, 2025, due to state funding cuts. Healthy Opportunities was active in 33 counties, and reduced costs due to improving social determinants of health. The Journal of American Medical Association determined that the program reduced costs by \$1000 per person served by the program. Innovations waiver slots for IDD not approved. Direct care workforce wage increases not approved. 1115 waiver to assist those incarcerated for re-entry not approved. Mr. Ludlam mentioned that Medicaid continues to work with the General Assembly with hope that above programs be funded.

Federal Update — the House and Senate have been working on the Reconciliation Package, which is an effort to continue the 2017 tax decreases and reform various programs. SNAP is in significant jeopardy with the current proposals. States and counties are expected to pay more for SNAP, or we may lose the program. North Carolina is expecting a \$2-3 billion dollar loss, which affects the continued funding of Medicaid Expansion and negatively impacts hospitals, especially rural hospitals. Persons will be required to re-verify multiple times per year which puts strain on Departments of Social Services. The start of these changes will be December 2026. Jay continued a high-level overview of the current federal funding proposal and its potential impact on North Carolina. He noted he would send talking points to Patrick Brown to disseminate to the Health Directors.

NACCHO Chief Executive Officer – Lori Tremmel Freeman

Dr. Jenkins introduced Lori Tremmel Freeman.

- Lori Tremmel Freeman provided a presentation to the Association, which will be shared via email.
- NACCHO is focused on directly supporting the local public health workforce and improving federal public health funding.
- Despite a negative outlook, there are still opportunities to focus on.

Discussion Points:

- The necessity of Federal, State, and Local support, with all three being crucial.
- Concerns about potential cuts to Federal support and their impact on state and local work.
- Ms. Freeman mentioned the possibility of pocket rescissions, which could remove federal funding 45 days before September 30, 2025 (mid-August). This would be detrimental to federal programs and is an existing tool expected to be used.

Additional Concerns:

- Issues regarding Vaccines for Children with ACIP changes.
- Mr. Freeman noted that support for FEMA might end after hurricane season.
- An expected over 50% cut to CDC funding.
- Lori highlighted multiple programs that could be eliminated.

Ms. Freeman shared resources to combat the current landscape. She mentioned a Northeast Public Health Collaborative made up of 10 states and jurisdictions in New England that are working together to move forward to fill gaps in public health due to funding cuts. Lori mentioned potential new CDC Director, Dr. Susan Monarez, with hearings occurring next week.

She closed with stating that we must focus on local control, which is something we can leverage at this time. She noted that across the nation most local health departments are providing billable clinic services. Ms. Freeman expects full elimination of Title X funding.

Executive Director Report - Patrick Brown

Patrick asked Health Directors to send advocacy outreach that Boards of Health have done. He mentioned the full association meeting in July will be delayed due to NACCHO 360 conference. He asked Health Directors to email Karen Davis if they are going to NACCHO.

Patrick shared that a strategic planning retreat would occur with officers in August and a survey to all Health Directors will be sent with the main topic being a revision of the Wednesday and Thursday meeting and committee structure.

HMA has begun Care Management workgroups with each Region. Patrick thanked the health departments that offered funding support.

Division of Public Health - Dr. Kelly Kimple

Dr. Kimple thanked everyone for their support. She noted regular meetings with NCALHD officers to discuss funding changes. DPH is moving forward and anticipating HIV funding, but Community Based Organizations received notification that funding is in question.

Dr. Kimple noted that local input is needed as we move forward, especially with TB funds. Three state level HIV staff have been eliminated due to funding cuts. Nine grants anticipated for July, and we expect a delay and a potential impact. State hiring freeze in place as we navigate future funding impacts at federal and state level.

Other updates from Dr. Kimple:

- Division of Public Health will be moving to a new complex near Blue Ridge Road in the coming years. No timeline.
- Dr. Larry Greenblatt became the State Health Director/Chief Medical Officer on June 2.

Deputy Director/Section Chief, Local and Community Support, DPH - Stacie Saunders

Stacie Saunders gave the following updates:

• Emails from Susan Little about AA 110 and 121 report completion.

- State Lab is resolving CLIA issues that impact local health department labs. Stacie asked Health Directors to notify her if locals didn't see resolution in next few weeks.
- Family planning survey more information to come in July.
- AA review and financial impact occurs mid-year and at end of fiscal year. Will be reviewed in July.
- Kathy Dall has a data walk available that can be used by locals. An email will be sent by Stacie.

Dr. Rod Jenkins thanked Stacie for her support with TB funding. Dr. Jennifer Green (Cumberland Co.) asked if smart sheets would be for both DPH and DCFW AAs. Patrick stated he would check on this.

DCFW Updates - Yvonne Copeland

Updates sent by email this morning.

Breastfeeding Peer Counselor Grant

DCFW received the Breastfeeding Peer Counseling grant, and it reflects a slight reduction from the previous year. Although the grant is reduced there are some unexpended funds we can apply. We think this will fill the gap for the upcoming federal year. AAs/Budget estimates for the period of Oct 1 25 - June 30, 26 will go out to LHDs early July.

Crossroads

Crossroads issues again this week due to a statewide network issue affecting other systems too. DIT is working on it. WIC directors have been notified about the problem.

Assistant Director for Community Nutrition Services (WIC & CACFP) Search

We have made an offer to a candidate and waiting for their response. Fingers crossed.

REHS Board Report - Lillian Koontz

Lillian Koontz provided a NCREHS update. Slide to be sent to Health Directors.

- EH associates only 4 received in NC and one remains working.

Meeting Called to Order - Dr. Rod Jenkins

President Dr. Rod Jenkins (Durham Co.) opened the meeting at 9:30 am and thanked everyone for attending.

Approval of Minutes - Joshua Swift

President's Report - Dr. Rod Jenkins

Dr. Jenkins thanked everyone for attending and asked for any new or retiring Health Directors. Courtney McFadden, Guilford County and Natalie Trachsel, Interim Polk County. Josh Kennedy's last day in Polk is July 27.

Executive Director Report - Patrick Brown

A retreat will occur in August with a survey distributed to the Association. The goal is to make the retreat an annual event.

Legislature reconvening next week. NCALHD will pay attention.

Patrick Brown named to the Governor's Advisory Committee on Cannabis.

Patrick appreciated all those who attended NACCHO and the great North Carolina representation.

Patrick is the Chair of the State Council of Associations this year (SACCHO). Patrick noted that NACCHO provided a training on connecting with representatives of Congress during the October recess and would share for those who were unable to attend.

HMA is developing a plan for Care Management planning going forward. The plan includes information on systems that can provide what Local Health Departments need. This report should be available next week.

NCALHD is aware of the Healthy Blue foster plan. These children are currently with Medicaid Direct and not CMARC. A call with Healthy Blue is being scheduled.

Medicaid Update - Melanie Bush, Assistant Secretary NC Medicaid

Ms. Bush delivered a presentation regarding the federal and state updates of Medicaid. The presentation was shared with the Association.

Key notes:

- Risk of losing Medicaid Expansion.
- Trigger law requires appropriate state funding to support Medicaid.
- 1 of 4 NC residents receive some form of Medicaid support.
- Work requirements to start December 31, 2026.
- Eligibility checks every 6 months.
- SFY 25-26 Medicaid rebase is now \$819 million. The legislature historically underfunds the rebase. In past years, COVID dollars made up the gap in funding.

Division of Public Health - Dr. Kelly Kimple

Dr. Kimple thanked everyone for their support.

Updates from Dr. Kimple:

- Thanked Stacie Saunders and Ryan Jury for working on the federal tracker tool.
- Tobacco funding from CDC may be reinstated as DPH was asked to submit a grant.
- Trump administration announcement of restricting access to non-citizens. This could impact Family Planning due to Title X funding.
- No state budget which has created a hiring freeze.

Deputy Director/Section Chief, Local and Community Support, DPH - Stacie Saunders

Stacie Saunders gave the following updates:

- Federal updates federal funding tracker developed.
 - Stacie shared the spreadsheet with name of grant, notice of award, status, and AAs associated with the grant funding.
- Fiscal Year 25 end of year report This is shared twice per year (mid-year and end of FY) to examine spending trends.
 - Stacie highlighted carry-forward AAs that can go from one fiscal year to the next. AA
 117, 121, 122 and 546 were highlighted.
 - "Bread and Butter AAs" were highlighted. These AAs provide core Public Health functions and not all funds are spent.

- Federal challenges with different mechanisms being used. Impoundment by delay in effect
 delays the ability to effectively spend all the funds. Sometimes new terms and conditions are
 added to restrict how funds are used.
- Funds are being managed at the account level versus at the specific program/activity level. CDC funding is from month to month.
- Seeing a rise in partial awards. Seeing an intentional shift to reduce funding of Public Health.
- State Lab CLIA Certificates to be resolved soon.
- Kerry Young sent the updates for Child Fatality Review and the agreements that must be signed and returned.

Dr. Rod Jenkins thanked Stacie for her support and the updates.

Patient Experience Overview/Follow-Up - Belinda Pettiford

Belinda gave updates regarding the Family Planning Patient Experience. This is a requirement for Title X and should be offered to clients, but they are not required to complete the survey. From the chat a question was asked if other surveys could be used to supply information to avoid duplication. Belinda asked for Health Directors to let her know what other surveys are being done. The goal is to connect the survey response back to Family Planning.

Patrick Brown asked that Amanda Blackwelder collect patient experience surveys from across the association. Health Directors instructed to send to Amanda by middle of the following week. Belinda offered to send out an implementation guide with a review in August.

DCFW Updates - Sharon Bell, Deputy Director of DCFW

Sharon stated that anticipated changes to SNAP would shift \$400 million in funding responsibility from the federal government to the state of North Carolina. Plus an additional \$65 million in administrative costs shifted to counties. These shifts would impact next fiscal year and could be impacted by error rates.

WIC Updates -

- Jennifer Green is the new Assistant Director for CNS which oversees WIC.
- WIC team is reallocating base caseload for those meeting above 100% of caseload with new allocations next month.

Epi Updates - Dr. Zack Moore

- HIV Dashboard Erika Samhoff shared a new dashboard that is available and will shared. The dashboard provides data at the county and zip code level.
- PFAs Kennedy Holt, Lead Environmental Health Epidemiologist, spoke regarding PFAs testing at landfills.
 - Eighty-six counties have at least one landfill with PFAs detection.
 - DEQ is determining if offsite private wells are affected.

- List of landfills affected is available to Health Directors.
- Adam Ulishney with DEQ is the best resource for questions adam.ulishney@deq.nc.gov 919-707-8210
- Bicillin Recall two-thirds of Local Health Departments affected by the recall. Dr. Mobley sent guidance to all Health Departments.
- COVID levels currently low but expect a summer surge.

Injury and Violence Prevention Branch Updates - Mary Beth Cox

Ms. Cox mentioned resources that are available.

- Alcohol Dashboard this has been rebuilt. More persons die from alcohol abuse than overdose.
 Alcohol outlet density data shared. Data shows that more availability of alcohol leads to increase for public health and public safety concerns. Data available by county. NC State Excessive Alcohol Advisory Committee meets regularly and if you would like to join please email substanceusedata@dhhs.nc.gov
- Overdose Data Dashboard site received facelift in December. NC-SUDORS (State
 Unintentional Drug Overdose Reporting System) which shows the information obtained from
 reviews of every overdose death in North Carolina. With 5 years of data, county level trends can
 be analyzed. Reach out to IVP for county level data. Data request form available for Health
 Directors to request information.

Environmental Health Report - Brady Freeman, Health Director Iredell County

- Mr. Freeman gave a reminder that all local health departments as part of the Consolidated Agreement have to enter into an annual agreement with DPH to provide Environmental Health.
- Mr. Freeman reminded everyone of the environmental health QA requirement. Per discussion, the onsite and well QA agreement should be submitted to the SWIFT team and the other program areas should be submitted to your regional.
- The NC DHHS- Environmental Health Section, in collaboration with the North Carolina Environmental Health Supervisors Association (NCEHSA) and the North Carolina Association of Local Health Directors (NCALHD), has developed standardized QA policies and templates to assist LHDs in meeting these requirements. These documents, available at the link below, represent the minimum standards that each LHD must meet.
- LHDs are welcome to exceed these minimum standards. However, if a department chooses to adopt the templates as-is, they may place them on local letterhead and submit them directly to the EH Section for approval.
- Section 4.7 of Session Law 2024-49 states:
 - "All local health departments shall enter into an annual agreement with the
 Department to provide environmental health services in accordance with Chapter
 130A of the General Statutes. The annual agreement shall include a requirement for
 quality assurance for all environmental health services."
- The "annual agreement" referenced above is interpreted as the **Consolidated Agreement**.

 Per the **FY26 Consolidated Agreement**, all local health departments (LHDs) are required to

submit Quality Assurance (QA) Plans to the Environmental Health (EH) Section, Division of Public Health, by **January 1, 2026**, for the following program areas:

- o Onsite Wastewater
- Private Drinking Water Wells
- o Childhood Lead Poisoning Prevention
- o Tattoos
- o Public Swimming Pools
- Child Care and School Buildings
